Welcome to the Spring 2021 issue of the ICUAS Association Newsletter.

Despite the COVID-19 challenges that we still face, we remain optimistic about our plans for the annual Conference, ICUAS'21. We proceed as planned; we believe that we are fully prepared such that the conference will be, again, a great success.

As you know, the 2020 Conference was delayed until September, while the 2021 Conference will take place at the same location and venue, in Athens, Greece, on June 15-18.

We are delighted to report that we have received 259 contributed/poster papers, the 3rd highest number of submissions. This is encouraging and allows for us to be optimistic about the acceptance, growth, respect, and appeal this annual meeting has earned. We commit to working even harder to serve our technical society in the best possible way, and to continuously provide updated information about the state-of-the-art in unmanned aviation.

All submitted papers went through a rigorous peer review process, where each paper had at least three (3) reviews. In addition, the Program Chairs, assisted by other members of the Organizing Committee, provided a fourth review for each paper. This process resulted in accepting 205 papers for presentation and inclusion in the Conference Proceedings. Table I shows the results per country.

As last year, ICUAS'21 will be hybrid, allowing for physical and virtual presentations. We will continue with regular updates via e-mails and on the conference web, and we are certain

that we will run a successful conference following all safety rules and protocols that will be in place this coming June.

We encourage you to actively engage and participate in the conference, virtually or physically. Moreover, do not hesitate to reach out to us for any information you may need.

Visa requirements

Greece is a member of the European Union (EU) and one of the Schengen Area countries – the world's largest visa-free zone. Individuals may click directly **https://www.mfa.gr/en/visas/visas-for-foreigners-traveling-to-greece/** and follow instructions for visa requirements.

Note that the Greek Ministry of Foreign Affairs provides detailed information on current visa requirements or find the nearest Greek Embassy or Consulate. Citizens of some countries need an entry visa for Greece. If you need a visa, make sure to apply for one well in advance.

To find out whether you need a visa to travel to Greece, follow the steps:

1. Go to the Hellenic Republic Ministry of Foreign Affairs,

2. Scroll down to the end of the page and find Services.

3. Click on Visas.

4. Click on **Visas for Foreigners travelling to Greece** and follow instructions.

Protocols for Arrivals in and Departures from Greece

According to the most recent official information, Greece will open its borders on May 14/15. We will keep on providing regular updates about the overall situation. You may click on **https://travel.gov.gr** for details. All travelers must complete the Passenger Locator Form (PLF) for the duration of their stay in Greece, including point of entry and departure, the duration of previous stays in other countries, and the address of their stay in Greece. One PLF should be submitted per family.

- Travelers will receive a confirmation email upon submission of the PLF.
- Travelers will receive the PLF with their unique Quick Response (QR) code on the day of their scheduled arrival in Greece and will be notified via email.
- Travelers boarding or embarking on the previous day of the arrival will be allowed to do so upon showing the confirmation email, since they will receive their QR code during their flight or voyage.

If anything changes, we will provide updates on the conference web.

Ms. Zoldi was admitted to the Bar of the Supreme Court of the Commonwealth of Pennsylvania in 1992, commissioned in the Air Force in July 1993, and served 25 years of active duty as a member of the Judge Advocate General's Corps (military attorney). She then spent two years with the Office of the Air Force General Counsel as the Business Matters Attorney for the U.S. Air Force Academy and an additional one on faculty as the Deputy Director of the Academy's Center for Character and Leadership Development. She is an internationally recognized expert on unmanned aircraft systems (UAS) and advanced air mobility (AAM) law and policy and a recipient of the Woman to Watch in UAS (Leadership) Award 2019.
